## РЕКТОРАТ

ORDER № РК36-1740 / 03.09.2021.

In connection with Art. 63c of the Health Act, Order № RD-01-748 of 02.09.2021 of the Minister of Health and on the grounds of Art. 44, para. 1, item 2 of the Regulations for the structure and activity of the Medical University-Sofia,

I ORDER:

I. Implementation of the temporary anti-epidemic measures for prevention of the risk of spreading COVID-19 in the structural units of the Medical University-Sofia until 31.10.2021 as follows:

1. The ongoing learning process in the structural units continues, observing a physical distance of at least 1.5 m and not more than 10 people in a room, wearing face masks, hand hygiene, regular ventilation every hour and disinfection in the following cases described below.

In connection with the complicated epidemiological situation, the lectures are held in an electronic environment, and the practical exercises are held in compliance with all anti-epidemic measures. In-person training of interns, doctoral students and postgraduates is also allowed. Exercises in an electronic environment are allowed at the discretion of the Deans of Faculties / Heads of the respective units /, in coordination with the heads of departments.

2. The holding of competitions and examinations is allowed when using not more than 30% of the capacity of the room in which no more than 30 participants are held, observing a physical distance of at least 1.5 m and wearing protective face masks from all participants.

3. Organization of the work process in the structural units in remote online form where possible, allowing the present work of a maximum of 50% of the staff;

4. Organization and control of the number of persons in the sites and in the premises, providing administrative services, not allowing more than 1 person per 8 m<sup>2</sup>

5. It is allowed to hold seminars, competitions, trainings in face-to-face form using not more than 30% of the capacity of the room, observing a physical distance of at least 1.5 m and wearing a protective mask by all participants.

6. The holding of team building and other organized group events of such nature in the labor collectives is suspended.

II. The deans of faculties (Heads of structural units) with their order to organize the implementation and control of the implementation of the introduced temporary anti-epidemic measures, in strict compliance with the requirements of the normative documents, as sending to the Rectorate of MU-Sofia:

1. Until 15.09.2021 a copy of his order to the attention of an expert SUKPB.

2. Until 15.09.2021, respectively until 15.10.2021, until 15.11.2021;

2.1. Report of the results of the educational process conducted in implementation of the point for the period of the introduced with temporary anti-epidemic measures to the attention of Deputy. Rector for Academic Affairs Prof. Dr. Karolina Lyubomirova, MD

2.2. Report on the planned and implemented anti-epidemic measures and organizational measures to ensure safety and health at work to prevent the risk of spreading COVID-19 to the attention of an expert SUKPB.

III. Order № PK36-1705 / 31.08.2021 is revoked.

This order shall enter into force on 07.09.2021.

I assign the control over the execution of the order to an expert from SUKPB in the Rectorate, MU - Sofia.
