FIRST PHASE OF DEVELOPMENT OF THE MEDICAL UNIVERSITY - SOFIA'S STRATEGY OF INTERNATIONALIZATION

Mission Statement:

Medical University – Sofia prioritizes the process of an ever-expanding international exchange of academic and research human resources that will lead to the emergence of strong interdisciplinary educational and scientific partnerships in which framework the future professionals could successfully realize themselves in a global competitive environment.

Vision Statement:

Having a trained well-trained workforce in the medical field is possible through the implementation of modern innovative approaches for international exchange of knowledge and skills, while developing: a well-established teaching methodology, traditions in the in-depth research process, and further using of acquired academic knowledge in competitive market conditions. The Medical University - Sofia considers as its medium-term strategic toolkit the existing possibilities for project international funding in the context of European Higher Education Area.

Current state

This Strategy of Internationalization of the Medical University – Sofia, hereinafter referred to as the Strategy, has been prepared on the basis of systematic and analyzed current university indicators in the context of the legal framework of the Bulgarian and European legislation in force. Internationalization as a term in the field of higher education refers to different manifestations of the process of involving an institution in various partner formats / alliances / unions, preparation and implementation of common international projects and initiatives, exchanged mobility, bilateral training abroad, international scientific exchange, cultural dialogue, etc. The current globalization process is driven primarily by market forces, at regional and international level, which force educational systems to adapt themselves to changing conditions.

The Strategy sets out key milestones and identifies key goals for the MU – Sofia that shall be achieved over the next 4-year programming period. The Strategy of Internationalization involves the preparation of University's documents containing objectives, actions and key performance indicators (KPIs). The soughtafter effect at the international level does not change the focus of the Strategy on its successfully implementation at local level: Department, Faculty or Academic Council of the Medical University - Sofia.

In order to respond adequately to the increasing demand to raise external funding, MU – Sofia shall invest in continuous enhancement and upgrading of the administrative staff's competences and capacities, using financial instruments as Horizon 2020, Horizon Europe, Programme Erasmus+, European Cooperation for

Technology and Science (COST), the Financial Mechanism of European Economic Area, etc. It is essential to develop and maintain contacts and partnerships at expert level with official representatives of the HRMD and coordinators of the Programme Horizon 2020/ Horizon Europe/ EEA.

SET OBJECTIVES AND IMPORTANT FEATURES OF THE STRATEGY OF MU – SOFIA AT THE FOUR LEVELS: NATIONAL, REGIONAL, EUROPEAN AND INTERNATIONAL

At the National level

The National Assembly of the Republic of Bulgaria in its Strategy for Development of Higher Education for 2014-2020 outlines the key priorities for the Medical University - Sofia. In this sense, the present Strategy is in line with the Bulgarian and European documents for the development of higher education.

At the beginning of 2019, the Council of Ministers of the Republic of Bulgaria initiated a series of changes regarding higher education institutions, as place emphasis on medical sciences as a field of particular importance to society and the economy. A number of measures have been taken in areas with an expected shortage of specialists. In medical professional fields, student enrollment at the national level has increased over 70% in recent years, according to data from the Ministry of Education and Science. In line with this national policy, the Medical University - Sofia as the oldest and most prestigious medical institution offering professional directions of national importance, should feel the beneficial effect of the initiated changes.

According to the Bulgarian legislation, the universities not only train specialists of high qualifications, but also develop science, culture and innovation (Article 6, paragraph 1 of the Higher Education Act). The law clearly states that each university has the right to organize international cooperation, membership in international organizations, conclude joint study contracts and contracts for joint research, project and innovation activities and other forms of joint activity with foreign higher education institutions and organizations recognized under the law of the country concerned.

At the European level

The Medical University – Sofia, as the leader in Bulgaria in all five fields of medical education - medicine, dental medicine, pharmacy, health care and public health, bears responsibility for the representation of the Bulgarian higher education at European level.

At the European level

Medical University – Sofia has clearly defined Rules for the admission of foreign nationals from EU Member States, EEA countries and so-called "Third parties", approved by Decision of the Academic Council from 25.04.2017. The Faculties of

Medicine, Dental Medicine and Pharmacy carry out courses in English. About 3,500 international students study at the MU - Sofia, in other words over 1/3 of all students are foreign students, and this greatly enrich the university environment with different cultures, value systems, multilingual communications and a variety of good practices.

Main Goals of the Strategy of Internationalization of MU - Sofia:

- ➤ **1st Goal:** Integration of the Medical University Sofia into the **European Education Area** by 2025;
- 2nd Goal: Integration of the Medical University Sofia into the European Research Area (ERA) by 2025;
- ➤ **3th Goal:** Increase the number of Inter-institutional agreements with higher education institutions from Programme and Partner countries under KA103 and KA107 in the framework of the Erasmus+ Programme;
- ➤ 4th Goal: Cumulatively increase of the international funding through participation in bilateral and multilateral projects and initiatives, emphasizing the importance of research process;
- ➤ **5th Goal:** Using the Erasmus+ Programme an essential tool for the sustainable development of the Institution and the achievement of the EU's strategic goals for the mobility and cooperation of young people with a European identity;
- ▶ 6th Goal: MU Sofia shall be represented in all important global and national rankings of higher educational institutions to get an international status;
- > **7th Goal:** Using cutting-edge technology to accelerate learning and teaching processes, as well as the modernization of material equipment in order to attract and expand transfer of knowledge.

Priority guidelines and measures for accelerated modernization and internationalization of Medical University – Sofia

The MU – Sofia should take concrete measures in two directions: internal organizational and structural modernization and external dimension: involvement of the University in the global process.

Organizational and structural changes in the MU - Sofia in the medium term:

- Building of a new Rectorate and renovation of the building stock: modernized offices and laboratories, as well as modern equipped centers for practical training;
- Awareness campaign (participation with information booth and presentation materials twice in the academic year) in order to inform students about the opportunity to benefit from funded mobility under the Erasmus+ Programme;
- Promoting international mobility (outgoing and ingoing students), but with targeted prevention of leaking of minds;
- Upgrading curricula and seeking intersections with market needs, not only in providing adequate practical knowledge, but also in fostering professional skills;
- ➤ Continuing process of sustainable development, in which the University provides higher specialized education, but is also a major center for the development of science, based on new scientific knowledge and application of modern information technologies.

Monitoring and updating of the Strategy of internationalization of the MU - Sofia

- The depth of the internationalization process of the MU Sofia should be measured with the depth of association with it and the intensity of its implementation;
- The quality of the offered services and the undertaken activities of the Medical University Sofia as a leading institution should be above the achievements at a

national level, equal to the regional average parameters and to the targeted goals at the European level;

- Level of use of innovation in training.

Risk Management

The Risk Management implies the Strategy of Internationalization in the context of the Organizational Strategy of MU – Sofia. Seven factors to consider:

- Reliable forecasting and effective targeting;
- An effective methodology for tracking costs while meeting the goals of internationalization;
- Developed an internal procedure for monitoring and update of the Strategy;
- Level of decentralization;
- Direction and depth of knowledge transfer;
- Leadership and organizational culture, as well as level of engagement of the participating countries
- Outcomes of the Risk management and implementation of the Strategy.
