

## INSTRUCTIONS-REGULATION FOR ALL RESIDENTS OF THE MU-SOFIA STUDENT DORMITORIES

### DEAR STUDENTS! BULGARIA IS NOW IN STATE OF EMERGENCY !

#### **The fight to reduce the spread of COVID-19 is our responsibility!**

In response to the Order of the Minister of Health, MU-Sofia issued Rector's Order (<https://www.mu-sofia.bg/en/order-by-the-rector-on-the-organization-of-the-educational-and-working-process-at-the-medical-university-sofia/>), stating that by 29.03.2020, and possibly additionally by 13.04.2020, distance learning will be introduced, and the way of teaching will be determined by each faculty.

During the declared State of Emergency in the country, and during your stay in the student dormitories of MU-Sofia you should observe the following **mandatory** rules:

1. Maintain high personal hygiene!
2. Wash and disinfect your hands regularly as instructed!
3. Use personal protective equipment such as masks, gloves, etc. when possible.
4. Limit the exits and walks outside the hostel!
5. Don't visit other students' rooms!
6. Do not accept people from outside or other residents of the dormitory in your room!
7. Do not attend or participate in the organization of mass events and gatherings, regardless of the occasion!
8. Avoid contact with people who have fever and cough.
9. In case of symptoms, immediately notify the competent medical authorities (your personal physician or tel. 112)!

#### **Dear students, using the dormitories of MU-Sofia!**

Failure to comply with these regulations, instructions and recommendations prescribed by the hostel management, university, state and health authorities, and in case a virus carrier or a sick person is detected, the possibility of quarantining the entire hostel is highly likely real!

During the declared State of Emergency, in case of violation of the ordinance, rules or measures issued against the spread or occurrence of COVID-19, the offenders shall be imprisoned for up to 5 / five / years and will be subject to fine of BGN 10 to 50 thousand, according to Art. 355, para. 2 of the Criminal Code of the Republic of Bulgaria.

Be aware that during the restoration of the learning and training activities' presence, the latter will be conducted by **introducing a step-by-step remote distance learning (in the form of electronic, audio or written training)**, according to the capabilities of each academic unit and the specifics of the non-clinical and clinical disciplines and subjects from the learner's curriculum.

Observe the provisions and instructions on your behavior during the State of Emergency in the Republic of Bulgaria, because your life and that of your colleagues, relatives, close relations and friends depend on that!
