ORDER № PK№36 / 31.03.2021

In connection with Art. 63v of the Health Act, Order № RD-01-194 of 30.03.2021 of the Minister of Health and on the grounds of art. 44, Para. 1, item 2 of the Regulations for the structure and activity of the Medical University - Sofia,

I HEREBY ORDER:

I. I amend and supplement Order № PK36-698 / 19.03.2021 as follows:

1. I introduce temporary anti-epidemic measures to prevent the risk of spreading COVID-19 in the structural units of Medical University-Sofia, as of 01.04.2021 to 30.04.2021:

1. 1. The educational process in a present form of the structural units of MU - Sofia shall be suspended until 11.04.2021

1. 2. Non-presence / hybrid electronic educational environment at the Medical University – Sofia shall still remain valid.

2. Exceptions shall be allowed for conducting seminars and practice exams in undergraduate and graduate programs from the professional courses of study " Medicine", "Dental Medicine", "Health Care", "Pharmacy" and "Public Health" and of state exams and PhD theses defences for all professional fields. In conducting the examinations it is necessary to:

- use no more than 30% of the capacity of the classrooms;
- have a duration of up to 2 (two) hours;
- keep a physical distance of at least 1,5 m;
- wear protective face masks;
- ventilate and disinfects the premises every hour.

3. Holding of congress-and-conference events, seminars, competitions, training timbuildings, exhibitions and other public events via physical attendance. The prohibition does not apply to competitions held in accordance with the Labor Code, the Law on the Academic Staff of the Republic of Bulgaria and other special laws.

II. To ensure safety and health at work, the Deans (Heads of structural units) must take the necessary organizational measures for the implementation of temporary anti-epidemic measures, in accordance with the type and nature of their activities, including :

1. Regular ventilation and disinfection of the working premises, according to Algorithm Appendix №1;

2. Giving instructions to employees for the maintainance of proper hand hygiene, according to Appendix №2 and securing the availability of warm water, soap and disinfectants;

3. Wearing protective masks for single or multiple use, in accordance with the recommendations in Annex № 3;

4. Organization of the work process in remote mode (remote work / home office), where possible, allowing physical presence at work of a maximum of 50% of the staff;

5. Organization and control of the number of persons in the sites and premises providing administrative services, not allowing more than 1 person per 3 sq. m.

III . The Deans (Heads of structural units) shall organize the introduction and control over the implementation of the temporary anti-epidemic measures introduced by this order, in strict compliance with the requirements of the normative documents.

IV. I amend and supplement item IV p. 2 of Order № PK36-698 / 19.03.2021 as follows:

2. Prepare a report on the planned organizational measures and actions to ensure the conduct of the training in completion of point I, item 2 for the period of the temporary anti-epidemic measures introduced by this order until 02.04. 2021.

This Order shall enter into force as of 01.04. 2021.

By April 8th, 2021 the structural units should send copies of their orders to the Rectorate of MU-Sofia to the attention of the expert SUKPB eng. M. Dashinov.

I assign the control over the execution of this Order to expert SUKPB of MU - Sofia.
