ORDER № RK36-2845 / 22.10.2021

Pursuant to Art. 32, para 1, item 1 of the LIO, in connection with the Decision of the AC of MU-Sofia from 21.10.2021, Order №RD-01-856 / 19.10.2021 of the Minister of Health, Order №RD-01-861/21.10.2021 and on the grounds of Art. 44, para. 1, item 2 of the Regulations for the structure and activity of Medical University - Sofia,

I HEREBY ORDER:

I amend and supplement item 1 of Order № RK36-2814 / 20.10.2021, as follows:

1. The educational process face-to-face may be carried out under application of item 31 of Order № RD-01-856 of 19.10.2021 of the Minister of Health, as follows:

a) 100% of the staff in the respective training site have been vaccinated or have suffered from COVID-19 or have a negative result from a pre-entry examination certified by valid documents for vaccination, illness or examination within the meaning of Order № RD-01-733 of 27.08.2021 of the Minister of Health or has the documents under item "bb") or item "cc") of this current item.

b) The necessary organization for admission to the educational site is provided only to persons who:

aa) have been vaccinated or have suffered from COVID-19, certified by valid documents for vaccination or illness within the meaning of Order № RD-01-733 of 27.08.2021 of the Minister of Health.

bb) present a negative result from a COVID-19 polymerase chain reaction test performed up to 72 hours before entering the training facility or a rapid antigen test (up to 72 hours before entering the training facility), certified by a valid document according to Order № RD- 01-733 from 27.08-2021. of the Minister of Health.

(cc) submit documents for a positive PCR test or a positive antigen or antibody test for a past period proving illness.

1a) By the meaning of this order, a valid vaccination document is the EU digital COVID certificate for incomplete vaccination course with a two-dose

vaccine according to Annex № 3 to item 1, letter "c" of Order № RD-01-389 of 31.05.2021 of the Minister of Health.

1b) For the purposes of this order only:

(a) EU digital COVID certificates for illness and similar recovery documents shall be considered valid from the 11th to the 365th day from the date of the first positive result of a PCR test or a rapid antigen test for COVID-19;

(b) EU digital COVID vaccination certificates shall be considered valid as follows:

(aa) the EU digital COVID certificate of completion of a single-dose vaccination course, from the date of vaccination;

(bb) the EU digital COVID certificate for completed vaccination course with a two-dose vaccine - from the date of the second dose of the vaccine;

(cc) the EU digital COVID certificate for an incomplete vaccination course with a two-dose vaccine, for a period of up to 30 days from the date of administration of the first dose of vaccine. "

1 g) For the period up to 11.11.2021 inclusive, the students and teachers who wish to be vaccinated shall be given this opportunity as follows:

During this period, Medical University - Sofia will provide the opportunity to conduct 4 antigen tests per student and respectively 2 antigen tests per lecturer. They will be provided at a pre-determined check-point by Medical University - Sofia, for which information will be available on the university's website.

1d. Language training in the Language Department and Sports continues to be online.

1e) The deans of faculties (Heads of structural units) with their order shall organize the implementation of item 1, as well as the control over the implementation of the introduced temporary anti-epidemic measures, in strict compliance with the requirements of the normative documents.

This order shall enter into force as of 25.10.2021.
