**ORDER No. RK36-1247/04.08.2022**

On the basis of Art. 32, para. 1, item 1 of the Higher Education Law, art. 44, para. 1, item 2 of the Regulations for the organization and activities of the Medical University-Sofia, order RD-01-248/03.08.2022 of the Director of the Sofia Regional Health Inspectorate (SRHI)

**I HEREBY ORDER:**

1. Temporary anti-epidemic measures are introduced for the Rectorate, the faculties, the Central Medical Library, as well as the other structural units of the Medical University - Sofia located on the territory of the Sofia - city district for 15 (fifteen) days, starting from 04.08.2022, as follows:

1.1. All persons, when they are in closed places that are accessible to citizens and/or intended for public use, are required to have a protective face mask for single or multiple use.

Exception from the obligation under item 1.1. allowed for:

- Participants in congress-conference events, briefings, press conferences and seminars during speeches (lectures, presentations, etc.) while observing a physical distance of 1.5 m from other participants.

- When directly serving people, requiring a distance of less than 1.5 meters, the use of a protective face mask is mandatory. As an exception, customer service without a protective face mask is allowed when mechanical partitions made of glass or other transparent material are provided, allowing wet cleaning and disinfection.

1.2. Anti-epidemic measures are organized in the workplaces as follows:

- Regular ventilation and disinfection;

- Denial of persons with symptoms of acute respiratory diseases (elevated temperature, headache, runny nose, cough, difficulty breathing, etc.) to the working premises;

- Observance by the staff of proper hand hygiene;

- Creation of an organization to ensure a physical distance between persons of at least 1.5 meters, and if that is not possible - wearing a protective face mask.

1.3. If possible and at the discretion of the relevant head of faculty/structural unit, to create the possibility of remote work or, accordingly, to establish working hours with variable limits, as well as limiting non-essential contacts at workplaces.

1.4. Regarding the provision of services to citizens or the organization of mass events, regardless of their nature, the following measures are additionally applied:

- To organize the activity in a way that ensures the observance of a distance of at least 1.5 meters between the persons to whom the relevant services are provided in the premises and the adjacent outdoor areas

- Placing information signs in a prominent place or informing service users in another appropriate way about the obligation to observe physical distance and wear protective face masks when visiting the relevant site

- Provision of administrative and other services to citizens through information and communication technologies whenever possible.

2. The deans of faculties (Heads of structural units) with their order to organize the implementation of item 1 of this order and to send a copy of their order to the Rectorate of MU - Sofia by 10.08.2022.

Order No. RK36-1182/02.08.2022 is revoked.

I assign the control over the execution of the order to an expert of Security, CM and FS in MU - Sofia, Rectorate.
